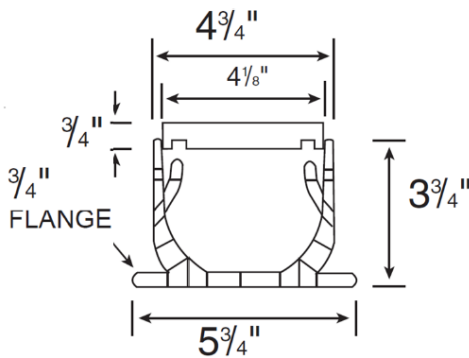
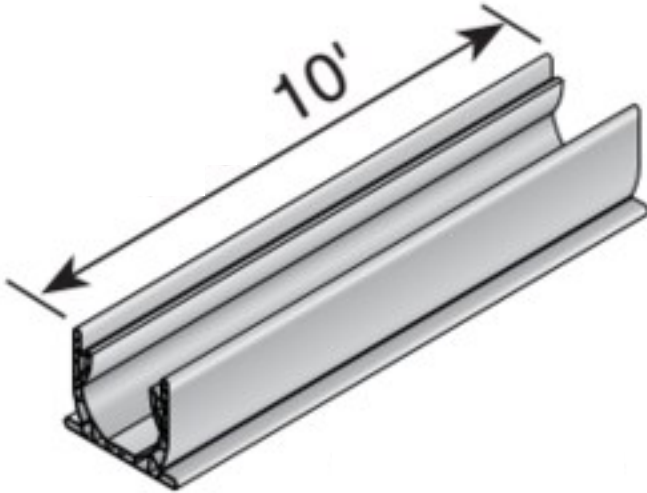


## 10' Spee-D Channel with Galvanized Metal Grate



### SPECIFICATION:

SPEE-D CHANNEL DRAIN - 4-3/4" OUTER WIDTH, 4-1/8" INNER WIDTH, 10 FT LONG NEUTRAL CHANNELS

THE CHANNEL IS MANUFACTURED FROM PVC, MADE IN THE U.S.A. AND CONNECTED WITH COUPLINGS (PART #248-SOLD SEPARATELY). THE #254 GRATES ARE MANUFACTURED FROM GALVANIZED STEEL AND PREFASTENED TO THE CHANNEL WITH THE REQUIRED #229 SCREWS. THE CHANNEL DRAIN SYSTEM CAN BE INSTALLED FLAT OR ALIGNED WITH A SLOPED GRADE AT THE SURFACE TO INTERCEPT SHEET FLOW DRAINAGE AND CONVEY IT TO AN APPROPRIATE OUTLET. ADA COMPLIANT.
